I, _____, in consideration for the opportunity to participate in the 2017 O2 5k at the SAS Championship (“Event”) and all related events and/or activities do hereby covenant with the SAS Championship (“Tournament”), SAS Institute, O2 Fitness, FS Series, Prestonwood Country Club, Octagon, Inc., the Interpublic Group of Companies, and their affiliates, subsidiaries, related entities, parent companies, and all of their officers, directors, representatives, agents, and employees, all vendors and contractors of the Event, and any sponsor, official or other person or entity associated with the Tournament and/or Event, that I shall not sue or bring any legal action or proceeding against any or all of them, or any member or owner, subsidiary or affiliate, director, officer, agent, employee, legal representative or successor or assign of any of the foregoing persons and entities (collectively, the “Releasees”) for or on account of any loss, damage, injury or death that I may sustain by virtue or arising out of my participation in or presence at the Event. I understand and acknowledge that the Event may involve activities that are not under the control of Releasees. These presents may be pleaded as a complete defense to any action or other proceeding which may be brought, instituted, or taken by me, my heirs or legal representatives against any or all of the Releasees in breach of this Waiver and Release, reserving unto me the right to proceed against any and all other parties which may be involved in such action or proceeding.

I acknowledge that my participation in the Event is without assumption of responsibility or risk of any kind by Releasees and Releasees do not make any representation or warranty of any kind with respect to the Event, and/or the suitability of the Event site. I understand the existence and assume the risk of all dangerous conditions arising from and inherent in the Event, and all related activities, and in transportation to and from the Event, and waive any and all specific notice of the existence of such conditions. I acknowledge that Event representatives have the right to dismiss, relieve or reassign me in connection with participation in the Event at any time and for any reason or no reason at all. I further agree that in case of any action being brought for or on behalf of me on account of any loss, damage, injury or death sustained by me while participating in the Event, any related activities, or in transportation connected with any of the foregoing, that I will be personally responsible and agree to repay to Releasees and defend and hold each of them harmless against any amounts recovered against any of them in connection with any such action and all related costs incurred by Releasees. I represent and warrant that I am in good health and have no physical conditions that may affect my ability to participate in the Event and have not been advised otherwise by a medical practitioner.

I further give SAS, Octagon, Inc., Tournament, and/or the Event, or anyone authorized by any of the foregoing parties the absolute right and permission in perpetuity to use, re-use, edit, publish and republish my name and biographical material about me and photographic portraits, pictures or video of me, or in which I may be included in whole or in part, or composite or distorted in character or form, in brochures and other materials which promote, publicize, advertise, and otherwise exploit the Tournament, the Event and/or SAS (collectively, the “Materials”). I waive any right that I may have to inspect or approve the finished product or the advertising or other copy that may be used in connection with the Materials or their use. I release and discharge the Releasees, and all persons acting under any of their permission or authority, from any liability by virtue of any blurring, distortion, alteration, optical illusion or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking of photographic portraits, pictures or video of me, or in any processing pertaining to completion of the finished product, unless it can be shown that it and the publication of it were maliciously caused, produced and published for the purpose of subjecting me to conspicuous ridicule, scandal, reproach, scorn and/or indignity.

I execute this Waiver and Release not in satisfaction of any damages sustained, or as compensation for injuries, or in settlement of any claim or damages. The opportunity to participate in the Event is consideration for the covenants and agreements contained herein. It is explicitly understood and agreed that the acceptance of the foregoing covenant by any of the Releasees is not an admission of any liability on its or their part and that each of them expressly denies any liability in any manner. This Waiver and Release shall be governed by and construed in accordance with the laws of the State of North Carolina, USA without regard to conflict of laws principles. This Waiver is a legally binding agreement and will be construed broadly to provide a release and waiver to the maximum extent permissible under North Carolina law. To the extent any disputes relate to, or arise from, this Waiver and Release, the parties acknowledge and consent to venue and the exclusive jurisdiction in the courts of, the Commonwealth of Virginia in the County of Fairfax or the United States District Court for the Eastern District of Virginia, Alexandria Division. If any provision of this Waiver and Release is found to be unenforceable or invalid, then such provision shall be ineffective to the extent of the court’s finding without affecting the enforceability or validity of this Waiver and Release’s remaining provisions.
